1. Introduction

The Improvements monitoring guidelines are aimed at providing a set of standard operating procedures for Improvements monitoring within the context of the DPME and Offices of the Premiers in the implementation of the Frontline Service Delivery Monitoring programme. The guidelines set out the rationale for improvements monitoring, the intended outcomes and the detailed approach for conducting improvements monitoring meetings and re-scoring visits.

2. Problem statement

Research conducted by the DPME shows that M&E has historically been a compliance activity, undertaken for vertical reporting, and not for improving performance. The FSDM's approach which is based on collecting baseline data, making follow up visits to develop improvement plans and lastly, the monitoring of improvements is therefore implemented to strengthen the M&E practices and to encourage the use of evidence for quick and decisive decision making as well as for systemic changes.

FSDM visits to facilities identified for improvements monitoring has over time indicated that after some time, the improvements implemented are not maintained nor monitored and things revert back (regress) to the original state found at the baseline stage. This practice is attributed to the lack of monitoring at the frontline and absence of accountability for quality of service rendered at the facility level. In addition, there is a high probability that

findings from the FSDM monitoring visits may not be acted on and that blockages identified may not be addressed in a quick and decisive manner.

Due to this, the FSDM initiative is progressively shifting its focus to the monitoring of improvements, to facilitate and monitor that the agreed actions are implemented. It is through this that the FSDM programme will continuously monitor those facilities selected for improvements monitoring to ensure sustainability of improvements.

3. Objective of the Improvements monitoring

The objective of FSDM in improvements monitoring is to facilitate improvements in the performance of targeted frontline service delivery sites and to drive the implementation of improvements at those facilities targeted for improvements monitoring due to poor findings. The focus is on facilitating a culture of change in government towards increasing use of evidence in policy making, planning and monitoring to inform improvements to plans and policies. Improvements monitoring focuses on identifying areas of weakness and to develop improvement plans with facility, district and provincial managers. Despite developing these plans with the assistance of the DPME, line departments are responsible for implementing the corrective measures.

Specific FSDM improvements objectives are:

- Instituting improvements urgently in severe cases identified through the FSDM monitoring visits, as a means of strengthening service delivery;
- Monitoring the implementation of improvement plans as developed by the line department together with DPME and OoP; and
- Monitoring the improvements in scores from the initial baseline visit scores with the scores after the implementation of improvement plans. The severity of the findings will however determine the level of DPME/OoP improvements monitoring oversight required over the implementation of improvement plans.

4. The approach and criteria for improvement monitoring¹

The Improvements Monitoring approach consists of 3 activities:

- Firstly, the DPME informs the national department (head office) senior management that a facility has been selected for improvements monitoring because of poor scores. The intention is for senior management to create an enabling and supportive environment in which facility-level managers can address the identified challenges.
- Secondly: a meeting is held at facility-level (led by DPME and OoP) to obtain progress with agreed improvements. The intention with this meeting is to facilitate acting on findings and to facilitate problem solving between the different role players.
- ➤ Thirdly: The unannounced monitoring of improvements are conducted, applying the same scoring questionnaire tool used for the first visit. A new score card is produced for the facility which reflects a longitudinal view of the scores, for each KPA, over time.

4.1 Criteria for selecting improvements monitoring facilities

The criterion for selecting facilities improvements monitoring is updated and reviewed yearly. This is in line with the fact that the process for improvements monitoring is influenced by the following factors:

- ➤ APP targets: The FSDM's APP targets for 15/16 state that 120 improvements monitoring visits (improvements meetings and re-scoring visits) will be undertaken. This includes new improvements monitoring facilities and old (previously remonitored) improvements facilities.
- > The dominant trends of the baseline monitoring visits. This means that each year, this section will be updated in line with the baseline findings and trends from the

¹ Not the same stakeholders who developed improvements plans attend the announced improvements meetings. The likelihood of interviewing the same citizens and staff is low. The timeframes is a minimum and provinces can motivate for longer periods.

current data collected from the baseline monitoring visits. In this regard, the 2015/16 approach will be influenced by the outcomes of the 2014/15 monitoring findings. Improvements monitoring processes of this current year (2014/15) will therefore be undertaken in the following FY year (2015/16). Only the selection of improvements monitoring sites will take place in this current year.

For 2015/16 for new improvements monitoring facilities, only those facilities that meet the following criteria will be monitored for improvements. Facilities that have the following scores:

- Staff scores will not be considered in selecting facilities that should be monitored for improvements as it is assumed that staff scoring creates room for biasness.
- If three (3) or more poor average (of citizen and monitor's ratings) KPA ratings are achieved in one facility, then that facility will be re-monitored for improvements.
 - This is illustrated in the example as per below using visibility and signage, queue management and complaints management as average KPA ratings for facility X:
- An average KPA rating of between 1-1.4 (Poor) as rated by both citizens and monitors counts as 1 poor KPA rating as below:

4.2 Improvements monitoring statistics for 2015/16

Based on the 2015/16 selection criteria for improvements monitoring these are the statistics for improvements monitoring facilities.

• New improvements monitoring facilities: 24 facilities were selected from the 2014/15 baseline visits (123 facilities). These facilities are as per the table below:

- For 2011/12 29 facilities were identified for improvements monitoring from the 135 facilities reported on. Due to the need for continuous improvements, these facilities have been re-monitored again in 2013/14;
- For 2012/13, 51 facilities were identified for improvements monitoring from 215 facilities monitored. These facilities have also been re-monitored in 2013/14 together with the 29 from 2011/12;
- From the 13/14 baseline visits, 43 facilities were identified for improvements monitoring.
- In 2014/15 (current year) 123 facilities were therefore re-monitored for improvements and this includes an additional 3 improvements facilities.
- In 2015/16 there's a target of 120 improvements facilities to be re-monitored by the FSDM programme. Due to the fact that there are already 123 improvements facilities that will need to be re-monitored from the historical list (2011-2013) in order to meet this target, some of the facilities will not be re-monitored by the FSDM programme (DPME) base on their performance since the first baseline.
 - These facilities are therefore taken out of the improvements monitoring list on the basis that they have shown improvements in scores over the 3 improvements monitoring cycle and significant improvements in terms of implementing improvement plans.
 - It is noted that should Provinces wish to re-monitor these facilities, they will need to utilise FSDM tools and follow the necessary quality assurance steps, if they are to be included as part of DPME reporting.

The following facilities will therefore, be taken out of the improvements monitoring list for 2015/16.

The table below highlights that the total for improvements monitoring visits for 2015/16 is 120. This is in line with the fact that from the historical list, 27 facilities were removed from a total of 123 improvements monitoring facilities and new improvements facilities (24) from the 2014/15 baseline visits were added. This is in line with the DPME target of 120 improvements visits in 2015/16.

Provinces are encouraged to do more improvements monitoring visits, should there be a need to do more. For DPME to report on these facilities, FSDM tools and quality assurance processes will need to be followed.

4.3 Conducting Improvements monitoring visits

Improvements monitoring approach consists of the following two independent but related steps/processes.

- Improvements meeting: a pre-arranged engagement with all stakeholders focusing on problem solving, uncovering of systemic challenges, confirming of short, medium, long term improvement actions, initial progress checking walk about and collecting reports. An Improvements Monitoring Template must be used in the meeting to track progress and for walk about activities.
- Improvements re-scoring: un-announced interviews of users and staff and scoring by monitors using the Improvements Monitoring Template.

For the two interdependent stages, tools that are utilised are listed in Annexure 2 attached. Improvements monitoring facilities are identified using selection criteria developed in line with findings of the preceding year and dominant trends across the sites monitored. Improvements monitoring is therefore undertaken in the year following that of the baseline

visits, and it is recommended that a **minimum of six (6) months** should pass before monitoring the facilities identified for improvements monitoring for the first time. Each facility identified for improvements will be visited twice, as part of the improvements monitoring processes described below:

4.4 Announced improvements monitoring meetings

The announced improvements monitoring meetings should take place at least six (6) months after the baseline monitoring visits. This is to ensure that enough time is allocated for the line departments to institute corrective measures as detailed in the improvement plans.

The announced improvements monitoring meeting should focus on tracking progress of the improvement plans developed as part of the feedback meetings and unearthing systemic challenges that may be hampering progress. The following stakeholders should be invited to be part of this meeting using the letter of invitation attached hereto as Annexure 1:

- Facility management;
- DPME/OoP;
- Sector district/regional management;
- Provincial management/representative from Provincial Management; and
- Official responsible for action item/s on the improvement plan (unless it is covered by the facility management).

In the improvements monitoring meeting, progress should be given by officials responsible for the action items. In instances where items have not been actioned, motivation and reasons will be documented. Items that have been implemented should be signed off at this meeting. Improvements monitoring meetings should be aimed at showing progress against identified items that need improvement. Attention should be paid to the following:

- Where all items as identified in the improvement plan have been fulfilled, that is, there has been progress to the satisfaction of all parties, there should be an agreement to sign off certification that the facility has improved in all areas identified. In this regard, the facility should be removed from the list of facilities identified for improvements monitoring.
- Where new items/issues (which were not listed as part of improvement plan)
 emerge during the improvements meeting, these issues should be packaged into
 the improvements re-scoring so as not to prolong the process of improvements

monitoring. These new issues should then be assessed with the facility management, which should write a report to the national and provincial management regarding the progress.

After the improvements monitoring meeting, in addition to tracking (ticking against) the actions on the improvement plan, the monitors should to do a walk about at the facility and verify if the items as discussed in the improvements meeting were implemented or not.

The findings of the observation are to be recorded on the improvements monitoring comments section as these comments are to be referred to when the monitor goes for the un-announced improvements re-scoring visit.

4.5 Un-announced improvements monitoring re-scoring visit

Un-announced improvements monitoring visits (re-scoring) will be undertaken to improvements facilities after the announced improvements monitoring meeting. The purpose of this visit is to monitor the facility through re-scoring the eight key performance areas in the questionnaire. In re-administering the questionnaire the focus is on getting a second score (rating) for the facility, after the implementation of improvements.

In re-scoring the facility, <u>all key performance areas will be re-monitored (re-scored)</u>, <u>however, when it comes KPAs with action plans, progress since the baseline or previous monitoring is to be provided</u>. When new scores are entered into the new improvements monitoring template, a regression, no change or improvement analysis will be detailed as per the table below:

In re-scoring the facility, the outcomes of the improvements meeting, that is, what the monitor observed regarding progress on the implementation of corrective measures during the improvement meetings, will influence the rating that the monitor allocates to each performance area in the re-scoring un-announced visit. This means that the monitor's rescoring ratings have more weight than the staff and citizen views. In other words, the monitor's second monitoring scores will have more influence of the improvements rescoring outcome: they are considered more credible than staff and citizen scores at this stage.²

The improvements monitoring visits (re-scoring) should be un-announced and only the DPME and OoP are to be part of this visit. Facility management will be handed the re-scoring findings before the FSDM monitors leave the facility and District and Provincial management will be forwarded the re-scoring findings at least 7 days after the un-announced improvements monitoring visit. The un-announced improvements monitoring visits should be preceded by baseline visits and announced improvements monitoring meetings. For clarification of what should be included in the improvements monitoring exercise, refer to the checklist attached as Annexure 3.

4.6 Improvements monitoring facilities with severe findings

Improvements monitoring facilities that are found to have severe findings following a baseline visit will be immediately (within a month) followed up for the development of corrective measures and for setting up a task team to drive the development of the improvement plans. Facilities with severe findings will consist of the following:

- Facility findings indicate total operational system collapse³ and the findings are not the norm for that sector;
- Facilities with severe findings with scores of ONLY poor and fair in all eight key performance areas;
- Facility findings (state of buildings, internal and external environment) warrants immediate action due to posing a health and safety risk⁴ to the lives of citizens and staff.

² This is to recognise the fact that in most cases, citizens interviewed may not have an idea of what the facility was like during the first visit as the possibility of new citizens being interviewed are large.

³ The site operates totally different from the expected norm, that is, SASSA office has no grants application processes in place or pay-out system administration.

Improvements monitoring processes for facilities with severe findings are outside the normal FSDM exercises and will be driven by a task team consisting of DPME, OoP, facility management and regional stakeholders. These stakeholders are required to meet regularly - at least once a month, until the completion of the process to ensure the planning and implementation of the improvements plans. The line department is responsible for the implementation of improvements while DPME and OoP will provide leadership in terms of driving the planning process and will provide oversight over the implementation process. The implementation of these service delivery improvements will also depend on the availability of budgets in the implementing department.

5. Reporting

The DPME is responsible for drafting the summary report after the improvements monitoring re-scoring, which must be submitted to the facility management. The facility management is responsible for submitting the report to its stakeholders, especially the principals. It should be standard practice for such reports to reach the provincial management, as they were part of improvements monitoring meeting.

When high-level reports, such as mid-year and annual reports, are distributed, the provincial management of the line department should receive copies as they are decision makers. Notwithstanding the protocols, facility management also need to be kept abreast of the findings that affect their facility.
