

# **Evaluation Update 14**

## September-October 2013

Evaluation Update is a summary of progress on establishing the South African National Evaluation System, led by the Evaluation and Research Unit of the Outcomes M&E Branch of the Department of Performance M&E in the Presidency (DPME). It is intended to keep stakeholders updated on progress. These two months have seen the development of the 2014/15 National Evaluation Plan, and most evaluations for 2013/14 underway. A very successful SAMEA Conference was held, including launching the Evaluation Repository and awarding the best government evaluation using the quality assessment undertaken for the Repository. Our work has been showcased at the American Evaluation Association and at a Evaluation Capacity Development Conference in Sao Paolo, Brazil.

## **Evaluations being taken forward**

4 of the 2012/13 evaluations have completed. 15 other evaluations are underway including 3 completing from the 2012/13 National Evaluation Plan, and 12 starting from the 2013/14 National Evaluation Plan. Annex 1 has the status on each of these as well as the proposed evaluations for 2014/15.

## **Development of policies and guidelines**

- Guidelines now available TORs for Evaluations, Guideline for Peer Reviews, Template for Evaluation Project Plan, TORs for Evaluation Steering Committees and Guideline for Inception Phase, Management Response, Improvement Plan, Communication, Provincial Evaluation Plans, Planning Implementation Programmes.
- 6 draft guidelines have been produced on Diagnostic Evaluation, Implementation Evaluations, Impact Evaluations, Economic Evaluations, Evaluation Synthesis and Evaluation Quality Assessment. These will be finalised in December.

#### Capacity development

- A training on the National Evaluation System was undertaken as part of the SAMEA workshop series, as well as one on Theory-Based Evaluation.
- The major training with the Centre for Learning on Evaluation and Results (CLEAR) has continued with Course 2 on Deepening Evaluation held in October. In addition part of Course 4 on Planning Implementation Programmes will be piloted in November, building on the Guideline produced in July. Course 3 on Methodology will be piloted in the New Year. DPME organised a training of MPs, which included a session on evaluation which was well-received.
- A course with UCT for Director/Deputy Director Generals on evidence-based policy-making and implementation will be held 18-20 November 2013 with funding from DFID. This will aim to build support from senior management for evidencebased policy-making and implementation including the use of M&E.

#### **Quality assurance**

A design clinic was held on 12-13 September to critique the emerging TORs for the 2014/15 Top international and evaluators participated and this proved a useful modality for helping to conceptualise evaluations.

## **Box 1: SAMEA Conference**

The South African M&E Association with DPME and the Public Service Commission organised the biannual SAMEA Conference entitled Meaningful Evaluation: Improving Use and Results from 18-20 September, and preceded by a number of workshops. Over 400 people attended including delegations from Uganda (including Ministers in the Presidency), Kenya, Benin.

One stream was organised by DPME and the Public Service Commission on government evaluations. Awards were given for the best government evaluation, building on the quality assessment undertaken for the evaluation repository, best paper amongst others. Collins Chabane, the Minister of Performance M&E and Administration in the Presidency spoke on the last day.

#### Research

 DPME is partnering with CLEAR to manage some research grants for doctoral or post-doctoral research on elements of DPME's work. The research should start in 2014.

#### **Evaluation and research evidence shared**

- Paper written for African Development Bank Publication, Evaluation Matters for September 2013.
- A successful SAMEA Conference was held in September 2013 on Meaningful Evaluation: Improving
  Use and Results (see Box 1). A repository of evaluations conducted for government since 2006 was

- DPME participated in two panels at the American Evaluation Association highlighting the work we are doing on evaluation, as well as participating in the UNDP Evaluation Capacity Development workshop in Sao Paolo.
- DPME is co-organising a **South-South Roundtable** in November with countries from Latin America, Africa and Asia on the demand & use of evidence in policy-making and implementation.

## Management

- National Evaluation Plan 2014/15 to 2016/17 15 evaluations have been selected (see Annex 2).
- **Departmental Evaluation Plans** three departments now have departmental plans: Trade and Industry; Science and Technology; and Rural Development.
- **Provincial Evaluation Plans** Western Cape Plan for 2013/14 and Gauteng have provincial evaluation plans. Free State, North West and Limpopo are in the process of developing one.
- Panel of service providers other government departments and provinces are now seeking to use the
  panel. Our procurement system is proving to be far faster and more efficient than most departmental
  systems. However there are weaknesses in the panel and training of the panel will be encouraged. A big
  weaknesses is only one university is actively bidding for evaluations so we are missing a major source of
  expertise.
- Staff two Directors started in September and we are interviewing for a research director. We also have an intern, Sanelisiwe.

#### Priorities for the next two months

- The first evaluations from the 2012/13 plan are completing and the processes of management response, improvement plans, and submission to cluster and Cabinet will be happening.
- Most of the 2013/14 evaluations are underway and the TORs will be developed for the 2014/15 evaluations.
- South-South Roundtable and course for Directors General, both focusing on evidence-based policy and implementation.
- Submission of the 2014/15 National Evaluation Plan to Cabinet for approval.

## Process after an approved final report

Note that once the evaluation report is approved as factually correct and methodologically sound by the Evaluation Steering Committee, the DG of DPME writes officially to the relevant DGs requesting a management response on the evaluation report within one month, and that work should start on the Improvement Plan. After this month a presentation on the evaluation findings is made to the relevant cluster, and then on to Cabinet. Once Cabinet has approved a letter is written to the relevant portfolio committee indicating that the evaluation has completed and they may want the department to present on the findings. The Improvement Plan addressing the findings should be completed within a maximum of 4 months of the approval of the report by the Steering Committee.
